Any claim received beyond the due date i.e.,04.08.2022 up to 5 PM shall not be entertained under any circumstances. However, IDCOL shall not be held responsible for non-receipt of such claims either due to postal delay or due to technical snag in e-mail. All vendors/concerned parties are also required to submit a No Dues Certificate (Other than the amount claimed) to IDCOL which shall be as on 31.03.2022. Further, the parties should also certify that on payment of the dues mentioned by them and agreed by IDCOL, Finance Department, there would be no further claims whatsoever. The creditors should also submit details of the bank account (Name of Account Holder, Account Number, Bank, IFSC Code) in which the outstanding amount needs to be credited along with the contact number and e-mail address of the authorized person. The settlement will be subjected to verification by IDCOL Finance Department and will be paid only if such amount is assessed as actually payable by IDCOL. Submission of false or misleading claims/proofs, undue claims against Debit Notes raised by IDCOL/Rejection of materials due to Quantity or Quality deviations / LD etc., wherein IDCOL has already rejected prior claims on said bills shall not be entertained and shall be subjected to legal proceedings.
